## SPAY/NEUTER CONTRACT & PURCHASE AGREEMENT

The undersigned fully understands and agrees that the purchase of the within described dog is for the purpose of a family pet ONLY and the dog is not to be used for breeding or show, other than obedience or other performance venues. The undersigned further agrees that they are not to receive the AKC registration papers on the said dog and said papers are being withheld by the Seller of said dog until such time as a certificate from a Veterinarian is presented to the Seller within \_\_\_\_\_ of the date of this agreement, as proof that the said dog has been neutered/spayed, at which time the AKC registration will then be delivered to the undersigned Buyer.

The Seller hereby guarantees the immediate health of described dog, meaning that it hasn't been exposed to any contagious or infectious diseases. Upon receiving a written diagnosis of illness of said dog whose illness is attributed to the seller, it may be returned for purchase price refund or exchange for another dog of equal value, to be determined by Seller. Said dog must be seen by your vet for a health check within the first 48 hours after purchase for the guarantee to apply. This puppy is guaranteed for any genetic or congenital defects that may be found up to, but not exceeding, 3 (three) years from the purchase date.

It is further understood and agreed if the Buyer can no longer own and care for said dog, at any time in the dog's life, the Seller reserves the right to be contacted and given first choice to either take back said dog, or help to place him in a suitable home. Said dog shall be returned to the Seller in a good and healthy condition, with its signed AKC registration. UNDER NO CIRCUMSTANCES shall the said dog be offered for sale or given away to anyone, until the Seller has been contacted.

As it is understood by the Buyer that said dog is being sold as "pet quality" no further guarantees, other than health and temperament are offered.

The Seller of the said dog shall have the prerogative of re-evaluation the said dog, if requested by the Buyer. In the event said dog is considered breeding quality or conformation quality, this agreement shall become null and void and a new agreement shall be effected. IT IS AGREED THAT ONLY THE SELLER SHALL HAVE THE AUTHORITY TO RE-EVALUATE SAID DOG.

BREACH OF ANY TERMS OF THIS CONTRACT ENTITLES THE SELLER TO REPOSSESSION.
